**Invitation for Expression of Interest (Eoi) for Development of MOOCs on  
SWAYAM Platform**

The University Grants Commission (UGC) hereby invites Expression of Interest (Eoi) from eligible faculty members of Higher Educational Institutions (HEIs) for the development of Massive Open Online Courses (MOOCs) across various disciplines to be offered on the SWAYAM platform.

**Eligibility Criteria:**

- The applicant must be a faculty member in a duly recognized institute/university/college, holding a Ph.D. degree with a minimum of 5 years of teaching experience in the relevant discipline.
- Faculty members employed in HEIs which are eligible to receive financial assistance from UGC as per the provisions of the UGC Act, 1956.
- Faculty members are required to submit a consent letter from their respective HEI for offering the online course through SWAYAM as per UGC (Credit Framework for Online Learning Courses through Study Webs of Active Learning for Young Aspiring Minds) Regulations, 2021.

**Scope of Work:**

### **Course Structure:**

Faculty members may determine the academic level and credit structure of each course in accordance with the National Credit Framework (NCrF), in alignment with the UGC Guidelines on Curriculum and Credit Framework for Undergraduate and Postgraduate Programmes. The courses shall be designed to equip learners with industry-relevant skills, enabling them to upskill in current technological and industrial trends, thereby enhancing their employability. Courses may be offered at either the Undergraduate (UG) or Postgraduate (PG) level, as deemed appropriate, ensuring academic rigor while maintaining institutional relevance.

- All financial disbursements shall be subject to quality assurance and compliance with MoE/UGC guidelines.

### **SWAYAM MOOC Structure:**

- **One Course introductory video:** A 5–7-minute course introductory video shall be developed, covering (course objectives, structure, brief about course content/curriculum, prerequisites, learning outcomes of the course, duration of the course, grading scheme, and number of credits offered) along with NCrF level and Industry linkage of the Course.
- **Week Introductory Videos (for every week):** A 1-2 minute video shall present an overview of the week's content and learning activities.
- **Week-wise Content Structure:** Each week/module shall comprise comprehensive learning materials designed to ensure academic rigor, student engagement, and industry alignment. The following components are to be included:
  - a. Course Content:** To be provided in the form of e-texts, videos, PowerPoint presentations (PPTs), along with self-assessment questions, graded assignments, learning activities, case studies, web references, research articles, and participation in discussion forums.
  - b. e-Text:** A well-structured e-text/e-book of approximately 3000 words, covering the entire topic in detail. It should include images, illustrations, case studies, research articles, references, and be accompanied by a PowerPoint presentation to aid visual learning.
  - c. Audio-Visual Content:** Structured video/audio material with animations (wherever applicable), simulations, virtual labs, and transcriptions, having a total duration of 25–30 minutes per module. To ensure sustained learner engagement, the content should be divided into shorter segments of 6–8 minutes each. Videos must conform to international production standards, include audio-visual educational graphics (AVEG), and integrate animations where applicable.

All content must be developed in strict adherence to the SWAYAM Guidelines, 2024, issued by the Ministry of Education, Government of India. The on-screen presence of faculty shall be limited to a maximum of 25% of the video duration, with the remaining time dedicated to animations, graphics, simulations, and other AVEG-based elements.

- d. Industry Vertical:** This feature is intended to equip learners with industry-ready skills by introducing current technological and industrial practices. It facilitates upskilling and enhances employability, aligning academic content with real-world applications and market demands.
- **Week sum-up videos:** A 1-2 minute video shall summarize the content taught during the week, and its outcome.
- **Discussion Forum:** The SWAYAM platform features a dedicated Discussion Forum to facilitate real-time doubt resolution. Course Coordinators, or their designated Teaching Assistants (TAs), are responsible for addressing and clarifying queries raised by learners in a timely and effective manner.
- **Assessment:** That includes multiple-choice questions, fill-in-the-blanks, matching Questions, Short and Long Answer Questions, Quizzes, Assignments, Discussion forum topics, and setting up FAQs, Clarifications on general misconceptions.
- **Live Classes:** Each course shall include at least one live session per week, with a minimum duration of 30 minutes, throughout the course period, which gives learning with in-person interactions, offering learners opportunities to engage directly with faculty, ensuring a comprehensive and smooth learning journey.

#### **Course Development Guidelines:**


- The Course Coordinator shall strictly adhere to the SWAYAM Guidelines-2024 issued by the Ministry of Education (MoE), Government of India. - MOOCs shall be developed in alignment with a multidimensional employment-focused approach and outlined in the above MoE-prescribed SWAYAM Guidelines-2024. ([https://swayam.inflibnet.ac.in/home\\_assets/download/SWAYAM%20Guidelines%202024.pdf](https://swayam.inflibnet.ac.in/home_assets/download/SWAYAM%20Guidelines%202024.pdf)).
- All course materials must undergo plagiarism checks, and plagiarism reports must be submitted to the host University/Institution and UGC.
- The Course Coordinator must ensure compliance with all directives issued by the UGC and MoE from time to time.

#### **Consent Letter:**

- A consent letter from the host University/Institution must be submitted, indicating formal approval to develop, deliver, evaluate, and certify the course under the SWAYAM program, following the standards set by MoE and UGC.

**Note:** All courses shall be designed with a focus on skill development and employment orientation, and must include appropriate industry linkage to ensure practical relevance and enhanced learners' employability.
