The following notification shall be published in the Andhra Pradesh Gazette.

NOTIFICATION

In exercise of the powers conferred by Sections 3 and 4 of the Andhra Pradesh State Educational Institutions (Reservations in Teachers' Cadre) Act, 2021, the Government of Andhra Pradesh hereby issue directions for identifying roster points and implementation of rule of reservation in all the State Educational Institutions under the administrative control of Higher Education Department, and in supersession of any orders/notifications/clarifications issued by the Government in the matter prior to commencement of the said Act No.19 of 2021, as follows:

The competent authority, for direct recruitment of faculty/teachers in the concerned State Educational Institution(s), either fully or partially funded by the State Government, as a single unit, shall follow the rule of reservation for direct recruitment against each class/category of vacant faculty/teaching posts to be notified in accordance with the Andhra Pradesh State and Subordinate Service Rules, 1996 as amended from time to time, including the directions/clarifications issued in this regard by the concerned administrative departments in Secretariat from time to time. For this purpose, each State Educational Institution :-

:: 2 ::

- a. shall obtain necessary approvals from the concerned competent authority viz., the administrative department of the Government / Head of the Department / statutory bodies of the Universities, as the case may be, for any changes in the names of the departments/subjects as per the needs of the time.
- b. shall clearly arrange all the vacant posts to be notified for direct recruitment, for each category of faculty/teaching positions, in alphabetical order of (i) departments, and (ii) the subjects, if any, within each department, well before issue of notification for the direct recruitment. After obtaining approval from the concerned competent Authority, the same shall be published in their website until finalization of recruitment process of that particular notification;
- c. shall identify the roster points for the said vacant posts to be notified and filled, in accordance with the Andhra Pradesh State and Subordinate Service Rules, 1996 for implementation of rule of reservation for direct recruitment of faculty/teachers into the State Educational Institution(s), and issue recruitment notification for the same.
