## ANDHRA PRADESH ACTS, ORDINANCES AND REGULATIONS Etc.,

The following Act of the Andhra Pradesh Legislature received the assent of the Governor on the 31<sup>nd</sup> December, 2019 and the said assent is hereby first published on the 3<sup>rd</sup> January, 2020 in the Andhra Pradesh Gazette for general information:

#### ACT No. 15 of 2020.

# ANACT TO AMEND THE JAWAHARLAL NEHRU ARCHITECTURE AND FINE ARTS UNIVERSITY ACT, 2008.

Be it enacted by the Legislature of the State of Andhra Pradesh in the Seventieth year of the Republic of India as follows,-

- 1. (1) This Act may be called The Jawaharlal Nehru Architecture and Fine Arts University (Amendment) Act, 2019.
- (2) It shall come into force on such date as the Government may by notification in the Andhra Pradesh Gazette, appoint.
- 2. In The Jawaharlal Nehru Architecture And Fine Arts University Act, 2008 (herein after referred to as a Principal Act) in section 1, in sub-section (1) for the words, "Jawaharlal Nehru", the words, "Dr. YSR". shall be substituted.
- 3. In the Principal Act, in section 2,-
- (i) in clause (3) for the words, "Jawaharlal Nehru", the words "Dr. YSR" shall be substituted.
  - (ii) in clause (23) the following words shall be omitted, at the end, namely,-

Short title and Commencement.

Amendment of Section 1.
Act 31 of 2008.

Amendment of Section 2.

"immediately before the commencement of this Act.". To send a little of the commencement of this Act."

Amendment of Section 3.

- In the Principal Act, in section 3,-
- (i) in sub-section (1), for the words, "Jawaharlal Nehru" the words, "Dr. YSR". shall be substituted.
- (ii) for sub-section (5), the following sub-section, shall be substituted, namely,-
- "(5) The headquarters of the University shall be located at such a place as determined by the Government within the limits of Kadapa District.".

Amendment of Section 29.

- In the Principal Act, for Section 29, the following shall be substituted, namely,-
- "29. The Colleges of Architecture and Fine Arts which were affiliated to or recognized by the Jawaharlal Nehru Architecture and Fine Arts University, Hyderabad at the time of bifurcation of the State and affiliated to the concerned University in the State of Andhra Pradesh subsequent to bifurcation shall be disaffiliated from the concerned University and shall be deemed to be affiliated to or recognized by Dr. YSR Architecture and Fine Arts University.".

Amendment of 6. In the Principal Act, for section 44, the following shall be substituted, namely,-Secrion 44.

Option for students to transfer to the Dr. Y S R Architecure University.

"44. Any student studying in any college, in any course under Jawaharlal Nehru Architecture and Fine Arts University shall be given an option to transfer to the Dr. YSR Architecture and Fine Arts University within such time as the University may determine upon its functioning provided the said courses are available in the University.

Provided that the student availing transfer shall be governed by the syllabi, curricula and the scheme for the conduct of examination and the conferment of degree, diploma or certificate, as the case may be, applicable to student under Dr.YSR Architecture and Fine Arts University.".

Amendment of 7. Section 45.

In the Principal Act, for section 45, the following Section shall be substituted, namely,-

shall be taken as per A.P. Reorganization Act, 2014.

Allocation "45. The teacher and other employees of the Jawaharlal Nehru Architecture and Fine Arts University shall be allocated to the State as per the provisions of the Andhra Pradesh Reorganization Act, 2014.".

Omission of Section 46 and 47. 8. In the Principal Act, sections 46 and 47 shall be omitted.
